- 4. How is resistance mediated or overcome? How might followers with differing opinions be enlisted towards a shared goal? Are some obstacles too great to overcome?
- 5. How can transformational leadership be both ad hoc in moments of crisis and sustained across a long-term vision?
- 6. How do leaders manage the push for transformational change while maintaining tradition?
- 7. How do we identify a failure of leadership? What are the dangers of failure and what are the lessons learned (individually, institutionally, and societally)?
- 8. How can leaders adapt to new technological innovations (past, present, and future) such as scientific advances, industrial advances, and artificial intelligence?
